

**RESOLUTION 93-36**

**A RESOLUTION OF THE RIDGECREST CITY COUNCIL  
APPROVING A SUMMARY VACATION OF A PEDESTRIAN  
ALLEY LOCATED ADJACENT TO LOTS 299, 300, 315 AND  
316 OF TRACT 1552, COMMONLY REFERRED TO AS 1012  
AND 1016 YORKTOWN STREET AND 1013 AND 1017  
RANGER STREET**

**WHEREAS**, the City Council of the City of Ridgecrest heretofore passed a resolution declaring its intention to summarily vacate the pedestrian alley located adjacent to lots 299, 300, 315 and 316 of Tract 1552.

**WHEREAS**, notice of the time and place for hearing all persons interested in or objecting to said proposed vacation was given in the manner provided by law under Chapter 4, section 8330 of the Streets and Highways Code; and

**WHEREAS**, said hearing having been held on June 16, 1993, at which time all persons interested in or objecting to said proposed vacation were heard:

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST  
RESOLVES:**

1. That it is found and determined that the pedestrian alley of Tract 1552 described hereinafter is unnecessary for present or prospective public access requirements.
2. That the following described pedestrian alley is herewith ordered abandoned and vacated:

All that portion of Section 8, T27S, R40E, MDM located in the City of Ridgecrest, County of Kern State of California. A strip of land 20' (feet) in width, bounded by lots 299, 300, 315 and 316 of Tract 1552 as recorded in Book 7 of Maps, Pages 88 through 92 in the Office of the Kern County Recorder, State of California; on the 11th of May 1950; also being bounded by Yorktown and Ranger Streets.

That subject to the exceptions and reservations of the abandonment and vacation, the City of Ridgecrest does hereby convey to lots 299, 300, 315 and 316 of Tract 1552 said 20' strip of land, said conveyances more particularly described as follows:

Lots 299 and 316 shall be conveyed a strip of land to adjoin their south property line and said land shall each measure 114' long by 10' wide and;

Lots 300 and 315 shall each be conveyed a strip of land to adjoin their north property line and said land shall each measure 114' long by 10' wide.

3. That subject to the exceptions and reservations of this resolution, the City of Ridgecrest does hereby convey to these benefited lots 299, 300, 315 and 316 of Tract 1552, the property described in Section 2 of this document.

4. That a certified copy of this resolution be recorded by the City Clerk in the office of the Kern County Recorder.
