

RESOLUTION 93-37

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIDGECREST PROPOSING PROCEEDINGS FOR ANNEXATION OF TERRITORY TO THE CITY OF RIDGECREST IDENTIFIED AS ANNEXATION NO. 15.

WHEREAS, the Planning Commission of the City of Ridgecrest, in accordance with the provisions of Section 65353 of the Government Code, held a public hearing on Tuesday, January 26, 1993, on the proposed annexation of certain properties to the City of Ridgecrest known as Annexation No. 15, notice of time and place of hearing having been given at least ten (10 calendar days before said hearing by publication in the Daily Independent, a local newspaper of general circulation; and

WHEREAS, by Resolution No. 93-04 on January 26, 1993, the Planning Commission recommended approval of the rezoning for the annexation area and this Council has fully considered the findings made by the Planning Commission as set forth in that Resolution; and

WHEREAS, the City of Ridgecrest desires to propose a change of organization, to wit, the annexation to the City of Ridgecrest of the hereinafter described territory, pursuant to Section 56800 of the Government Code of the State of California.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGECREST RESOLVES:

1. That the City of Ridgecrest hereby proposes the annexation to the City of Ridgecrest of the territory described in Exhibit "A" and shown on map marked Exhibit "B", attached hereto and made a part of this resolution as though fully set forth herein.

2. That a plan for providing services within the affected territory of the proposed annexation, in accordance with the provisions of Section 56653 of the Government Code, is marked as Exhibit "C", attached hereto and made apart hereof as though fully set forth herein.

3. That this proposal for change of organization, to with, annexation, is made pursuant to the Cortese-Knox Local Government Reorganization Act of 1985, and it is requested that proceedings be authorized for annexation in accordance therewith.

4. That the reasons for the proposed change of organization are that the owners of the affected territory desire to receive municipal services from the City of Ridgecrest, and the City desires to receive tax revenues for benefits given and to be given to the territory proposed to be annexed.

5. That for this proposed annexation and the rezoning therefore, Resolution PC. 93-01, which was adopted January 26, 1993, an Initial Study was conducted and it was determined that the proposed project would not have a significant effect on the environment. A Negative Declaration was prepared and posted on June 2, 1993.

6. That the laws and regulations relating to the preparation and adoption of Negative Declarations as set forth in the California Environmental Quality Act and the City of Ridgecrest have been duly followed and the Negative Declaration for this proposed annexation is hereby approved and adopted.

7. That the territory proposed for annexation as described herein has been determined to be uninhabited pursuant to the Cortese-Knox Local Government Reorganization Act of 1985, Section 56046 of the Government Code.

8. That the names of the officers of the City of Ridgecrest who are to be furnished with copies of the Executive Officer's Report and who are to be given mailed Notice of Hearing, if any, are:


