WHEREAS, the United States Congress has enacted the Transportation Equity Act for the 21st Century of 1998, which is intended to provide federal dollars over a 6 year period as matching funds to local, state and federal agencies and nonprofit entities for Regional State Transportation Plan (RSTP) projects; and

WHEREAS, the Department of Transportation has established the procedures and criteria for reviewing proposals and is required to submit to the California Department of Transportation Commission a list of recommended projects from which the recipients will be selected; and

WHEREAS, said procedures and criteria established by the California Department of Transportation resolution certifying the approval of application by the applicants governing body before submission of said application to the California Transportation Commission and the State of California; and

WHEREAS, the application contains assurances that the applicant must comply with; and

WHEREAS, the applicant, if selected, will enter into an agreement with the State of California to carry out the Regional State Transportation Plan (RSTP) projects;

NOW, THEREFORE, BE RESOLVED that the Ridgecrest City Council:

- (1) Approves the filing of an application for the Regional State Transportation Plan (RSTP) Program for consideration for funding.
- (2) Certifies that said applicant will make adequate provisions for operation and maintenance of the project.
- (3) Appoints Harry Jensen, City Administrator, or his designated representative, as agent of the City of Ridgecrest to conduct all negotiations, execute and submit all documents, including but not limited to application, agreements, amendments, payment request and so on, which may be necessary for the completion of the aforementioned project.




