**A RESOLUTION OF THE RIDGECREST CITY COUNCIL
ESTABLISHING UNMET AND REASONABLE TRANSIT NEEDS
FINDING**

WHEREAS, The Transportation and Development Act Statues and Administrative Code for 1982 requires that before any allocation of Transportation Funds is made for a purpose not related to public transportation services that a public hearing be held to determine if there are Unmet Transit needs, that are reasonable to meet; and

WHEREAS, a public hearing was held at the regular meeting of the City Council on March 19, 2003, for the purpose of receiving public testimony on Unmet and Reasonable Transit Needs; and
