

**RESOLUTION NO. 05-23**

**A RESOLUTION OF THE RIDGECREST CITY COUNCIL AUTHORIZING RE-ALLOCATION OF COMMUNITY DEVELOPMENT BLOCK (C.B.D.G.) GRANT FUNDS FOR STREET RECONSTRUCTION ON SUNSET STREET BETWEEN UPJOHN AVENUE AND RIDGECREST BOULEVARD AND AUTHORIZING THE CITY MANAGER TO SIGN AN AMENDMENT TO THE AGREEMENT WITH THE KERN COUNTY DEPARTMENT OF COMMUNITY DEVELOPMENT**

**WHEREAS**, a Community Development Block Grant (Agreement No. 175-202) was received by the City of Ridgecrest for reconstruction of Sunset Street from Upjohn Avenue to Ridgecrest Boulevard, and,

**WHEREAS**, the necessary right of way could not be obtained on Sunset Street from Church Avenue to Ridgecrest Boulevard, and, the City of Ridgecrest has the necessary right of way on that segment of Sunset Street between Upjohn Avenue and Church Avenue, and,

**WHEREAS**, the City of Ridgecrest desires to re-allocate those funds for the reconstruction of Sunset Street from Church Avenue to Ridgecrest Boulevard in the amount of one-hundred sixty one thousand thirty dollars (\$161,030) for the reconstruction of Wilson Avenue and Upjohn Avenue between Sunset Street and Norma Street, and,

**WHEREAS**, future phases of the project will consist of design and reconstruction of (1) Sunset Street from Upjohn Avenue to Church Avenue and (2) Church Avenue, Radar Avenue and the frontage road along Bowman Road between Sunset Street and Norma Street, and,

**WHEREAS**, re-allocation of the one-hundred sixty one thousand thirty dollars (\$161,030) requires an amendment of the agreement for the reconstruction of Sunset Street from Upjohn Avenue to Ridgecrest Boulevard (Agreement No. 175-2002) between the Kern County Department of Community Development and the City of Ridgecrest.

**NOW THEREFORE**, the City Council of the City of Ridgecrest does hereby re-allocate one-hundred sixty one thousand thirty dollars (\$161,030) from the Community Development Block Grant funds for the reconstruction of Sunset Street from Upjohn Avenue to Ridgecrest Boulevard for the reconstruction of Upjohn Avenue and Wilson Avenue between Sunset Street and Norma Street and authorizes the City Manager to sign the amendment to said agreement (Agreement No. 175-2002) with the Kern County Department of Community Development which allows for said re-allocation.


