

RESOLUTION NO. 07-58

A RESOLUTION OF THE RIDGECREST CITY COUNCIL RESCINDING RESOLUTION NO. 07-55 AND AUTHORIZING CITY MANAGER TO ENTER INTO CONTRACT WITH DE FRENCHI POOL PLASTERING IN THE AMOUNT OF \$85,000 FOR THE RE-PLASTERING AND TILE REPAIR AT PINNEY POOL AND TO AUTHORIZE BUDGET TRANSFER

WHEREAS, On September 21, 2007 bids were solicited locally and out of town for the Re-Plastering and Tile Repair at Pinney Pool. On October 31, 2007 bids were accepted and opened. Two responsible bids were received.

1. South Coast Pool Plastering, Inc. from Lakeside, CA \$55,900.00
2. De Frenchi Pool Plastering from Bakersfield, CA \$85,000.00 ;and

WHEREAS, On November 7, 2007 the City Council Approved to award contract to South Coast Pool Plastering in the amount of \$55,900.00 (Resolution 07-55). On November 8, 2007 South Coast Pool Plastering notified the City of Ridgecrest that they had made a clerical error and were requesting to be disqualified as low bidder; and

WHEREAS, Staff has checked the references from second low bidder De Frenchi Pool Plastering and each reference called was pleased with the job that De Frenchi Pool Plastering had completed; and

WHEREAS, Staff is recommending to City Council to Rescind Resolution No. 07-55 and authorize City Manager to enter into contract with De Frenchi Pool Plastering in the amount of \$85,000 for the Re-Plastering and Tile Repair at Pinney Pool and authorize budget transfer of \$10,000 from account 001-4630-463.46-01 75PNY to account 018-4660-460.46-01 PK0801.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Ridgecrest approves to Rescind Resolution No. 07-55 and authorize City manager to enter into contract with De Frenchi Pool Plastering in the amount of \$85,00 for the Re-Plastering and Tile Repair at Pinney Pool and authorize budget transfer of \$10,00 from 001-4630-463.46-01 75PNY to account 018-4660-460.46-01 PK0801.


