

RESOLUTION NO. 08-32

A RESOLUTION OF THE RIDGECREST CITY COUNCIL APPROVING THE IDENTIFICATION OF H. M. HOLLOWAY LANDFILL AS A PROPOSED IWMP CSE, AND A PUBLIC HEARING FOR THE AMENDMENT OF THE KERN COUNTYWIDE SITING ELEMENT TO INCLUDE THE H. M. HOLLOWAY LANDFILL

WHEREAS, H. M. Holloway, Inc. currently owns and operates the H.M. Holloway Landfill, a permitted facility located two miles north of State Route 46 on Holloway Road, in the unincorporated area of the County; and

WHEREAS, H. M. Holloway intends to modify the Solid Waste Disposal Facility, amend the Kern County General Plan, obtain Conditional use Permit (CUP) for a Sanitary Landfill, modify the existing CUP, rescind a previous CUP, and obtain a Solid Waste Facility Permit; and

WHEREAS, the Kern County Countywide Siting Element needs to be amended to reflect the inclusion of this facility; and

WHEREAS, the Kern County Waste Management Department has prepared a report recommending that this Council make a finding that the inclusion of the H.M. Holloway Landfill is in conformance with the Kern County Countywide Siting Element; and

WHEREAS, in its investigation and evaluation of possible environmental impacts of this project, the Waste Management Department has used the Draft Environmental Impact Report prepared by the Kern County Planning Department for the amendment and approved by the Kern County Board of Supervisors on April 1, 2008; and

WHEREAS, the City Clerk has caused notice to be duly given of a public hearing in this matter in accordance with law, as evidenced by the affidavit of publication and the affidavit of mailing on file with the City Clerk; and

WHEREAS, at this public hearing this Council duly approves the amendment of the Siting Element, approving the inclusion of the H.M. Holloway Landfill and the report and recommendations of the Department and all interested persons were given the opportunity to address and were heard by this Council; and

WHEREAS, all persons desiring to be heard in said matter have been duly heard, and this Council having considered all testimony presented during said public hearing and the report and recommendations of the Department having been concluded; and

3. The City Clerk shall cause a copy of this Resolution to be sent to Katrina Slayton of the Kern County Waste Management Department.




